Who We Are

We are TradesMind AI Ltd, the company behind TradesMind AI — the voice-first business assistant for UK tradespeople. When we say "we", "us", or "our", we mean TradesMind AI Ltd. We are the "Data Controller" for your personal data. Questions about your data? Email us: privacy@tradesmind.ai

What Data We Collect

When you sign up and use TradesMind AI, we collect:

- Your name, email address, mobile number, and business name.
- The voice recordings and transcripts of your conversations with Max, our AI assistant.
- Your business records — jobs, clients, invoices, quotes — created through the platform.
- Emails you send or receive through the platform's email feature.
- Technical data about how you use the platform (log-ins, page views, device type).
- Your subscription and billing status (not your full card details — those go to Stripe).
- Your preferences and settings.

Why We Collect It

We collect your data to:

- Run the platform and give you access to Max and all the business tools.
- Remember your business context so Max can give you relevant, personalised help.
- Send you the emails and notifications you ask for.
- Bill you correctly for your subscription.
- Improve the platform and fix problems.
- Contact you about updates and new features that are relevant to you.
- Comply with the law.

Marketing — Your Right to Know

As a TradesMind customer, we may occasionally contact you about new features, offers, or updates to the platform. UK law allows us to do this for our own similar products and services without asking for a separate opt-in — this is known as the "soft opt-in". However, we will always give you an easy way to opt out. Every marketing email has an unsubscribe link. You can also turn off marketing in Settings > Notifications & Alerts, or email privacy@tradesmind.ai. We do not sell your data to anyone. We do not share it with third-party marketers.

Who We Share Your Data With

We only share your data with companies that help us run TradesMind AI:

- Anthropic — the AI technology that powers Max's conversations.
- VAPI — the voice call technology that lets Max answer your phone.
- Supabase — our secure database, hosted in the UK/EU.
- DigitalOcean (London) — the servers that run the platform.
- Stripe — handles all card payments. Stripe is fully PCI compliant.
- SendGrid — sends emails on our behalf.
- Google or Microsoft — only if you connect your Gmail or Outlook account.

How Long We Keep Your Data

- While your account is active: we keep all your data so the platform works properly.
- After account deletion: most data is deleted within 30 days.
- Billing records: kept for 7 years (HMRC requirement).
- Anonymised usage data: kept indefinitely — it cannot identify you.

Your Rights

You have the right to:

- See the data we hold about you (Subject Access Request).
- Ask us to correct data that is wrong.
- Ask us to delete your data (right to erasure).
- Ask us to stop using your data for marketing.
- Get a copy of your data in a format you can take elsewhere.
- Make a complaint to the Information Commissioner's Office (ICO) at ico.org.uk.
- To use any of these rights, email privacy@tradesmind.ai. We will respond within 30 days.
